2025 SCHOOL FEES (GRADE 1 - GRADE 7)

The paying of school fees at Freeway Park Primary School is compulsory. School fees are a statutory debt and failure to pay fees (in terms of Section 41 of the School Act) will result in legal action being taken to recover outstanding fees. All costs will be for your account.

SCHOOL FEES FOR GRADE 1 FOR 2025:

R972.00 PER LEARNER PER MONTH (for 11 months).

R10 692.00 PER ANNUM - FOR EACH LEARNER
STATIONERY - R 1 300.00

SCHOOL FEES FOR GRADE 2 - GRADE 7 FOR 2025:

R972.00 PER LEARNER PER MONTH (for 11 months).

R10 692.00 PER ANNUM - FOR EACH LEARNER

School fees must be paid on the 1st day of each month from January to November.

NOTE: First monthly payment is due on the 1st January 2025

Should you wish to pay in full, the following discounts will apply:

1. School Fees paid in full by 31 December 2024 - 10% discount (R9 623.00 to pay).
2. School Fees paid in full by 31 January 2025 - 8% discount (R9 837.00 to pay).
3. School Fees paid in full by 28 February 2025 - 6% discount (R10 050.00 to pay).
4. School Fees paid in full by 31 March 2025 - 5% discount (R10 157.00 to pay).
